Kerbside Landfill Waste, Recycling and Organic Collection Policy

#### PURPOSE

The aim of this policy is to outline the standard kerbside collection provided to service entitled properties across the Greater Shepparton municipality.

#### OBJECTIVE

Council is committed to reducing waste to landfill by ensuring that kerbside collection services facilitating the segregation of waste at the source are available to as many domestic residences within Council area provided it is economically feasible.

#### SCOPE

This Policy applies to all Service Entitled Properties on the principle of equity to all residents.

#### DEFINITIONS

#### POLICY

#### 1. Urban and Rural Waste Service Provision

- 1.1 This Policy applies to all Service Entitled Properties on the principle of equity to all residents. Council is entitled to charge Service Rates and Charges for the collection and disposal of refuse under the Local Government Act, 1989.
- 1.2 Council will provide a Standard Kerbside Collection Service consisting of:

Weekly Landfill Waste collection;

Fortnightly mixed Recyclables collection;

Fortnightly Food and Garden Organics collection.

120 litre Landfill Waste Bin (red lid);

240 litre Recycling Bin (yellow lid);

240 litre Organics Bin (lime green lid); and

a Kitchen Organics Caddy with access to compostable liner bags;

where available to that Service Entitled Property.

- 1.3 Households rated residential and rural residential located within urban boundaries regardless of the size or type of the property must have a Standard Kerbside Collection Service (1 x landfill waste bin, 1 x recyclables bin and 1 x food and garden organics bin).
- 1.4 It is acknowledged that some residents may require a different combination of bin sizes than that outlined in the Standard Kerbside Collection Service. Variations to the Standard Kerbside Collection Service will either be in accordance with Kerbside Landfill, Recycling and Organic Waste Collection CEO Directive or through application to and approval of Council – additional or reduced fees and charges may apply.
- 1.5 All Mobile Garbage Bins, Mobile Recyclables Bins and Mobile Organics Bins will be hot stamped with Council's logo as required.
- 1.6 Current available waste service choices are:




Appendix A - PLANS OF URBAN ZONES FOR ORGANICS COLLECTION




















